[^0]:    ${ }^{1}$ ARTICLE 3 DIRECTORS, SECTION 8. REGULAR AND ANNUAL MEETINGS At an annual meeting of directors held during the first quarter of the calendar year, directors shall be elected by the Board of Directors in accordance with this section. The board will be elected in slate fashion, with the highest vote-getting slate proposed by any board member or nonvoting general member becoming the governing body for the year. Cumulative voting by directors for the election of directors shall not be permitted. The slate receiving the highest number of votes up to the number of directors to be elected shall be elected. Each director shall cast one vote, with voting being by ballot only.
